DEFINITIONS: PSTN means public switched telephone number. Standard IP data service is offered on a best effort basis without a data rate guarantee; KB means kilobyte of data; MB means megabyte of data; CDR means call detail record.

BILLING: Customer's prepaid account is billed for all data and calls sent or received through the BGAN terminal. Standard IP access sessions are billed in 10 KB increments with 50 KB minimum per "session CDR"; a session CDR is generated for every 2 MB of usage or every 12 hours of connection time, whichever comes first. Voice is billed in 15 second increments with a 30 second minimum per call. Short Message Service (SMS) messages have a 160-character limit, and charges apply for each addressed recipient. Call details are not available for BGAN prepaid service.

SPECIAL LIMITATIONS ON BGAN PREPAID SERVICE: Customer acknowledges that if he/she allows the BGAN Prepaid account to reach a zero balance that he/she will not be able to use the BGAN terminal for voice, SMS, or internet communication. The Customer will remain liable for the equipment rental fees even if their BGAN Prepaid balance is zero.

- The Customer can check their BGAN Prepaid balance or reload their prepaid account by calling Outfitter Satellite during regular business hours.
- Streaming IP and ISDN service are not available on this plan.
- Voice calling from the BGAN terminal requires the optional Voice Handset for the BGAN.
- Voice calls from the BGAN can only be made while outside the United States (due to ongoing patent litigation).
- Any existing prepaid account balance will be lost if the customer chooses to switch the SIM to any other service plan.

BGAN PREPAID RELOAD AUTHORIZATION: Customer authorizes the use of his/her credit card account for future ONLINE, email, and over-the-phone transactions to purchase prepaid vouchers to be applied to the Customer's prepaid account(s). Customer can reload at anytime during the rental during Outfitter Satellite's regular business hours but must allow 4-6 hours to process the reload. A 250-unit or larger reload can be placed with technical support 24/7 but the Customer understands it can take 4-6 hours to process and appear on the Customer's account. **VALIDITY PERIOD OF PREPAID USAGE:** The prepaid usage will last for the duration of the rental. After the rental is concluded any unused prepaid usage is lost.

ISATPHONE PRO AIRTIME CHARGES

Customer pays any tax & USF above rates shown.

The ISATPHONE PRO is an Inmarsat GSPS (Inmarsat Global Satellite Services) system. Airtime usage during any given calendar month is billed (postpaid) in the subsequent calendar month (though occasionally a greater time lag occurs). The Customer agrees to pay for all calls made or received on any Isatphone PRO rented under this agreement as shown in the GSPS postpaid rate chart (shown to the right). All calls are measured and charged in 60-second increments. Airtime invoices with call detail records will be sent to your email address of record. If the Customer uses the IsatPhone PRO texting features, SMS charges apply for each addressed recipient even if the SMS message is not received.
