FUTURE RELOAD AUTHORIZATION

CUSTOMER AGREES THAT ANY RESULTING CHARGES BY OUTFITTER SATELLITE TO ANY CREDIT CARD ACCOUNT AUTHORIZED FOR PURCHASES ON THE CUSTOMER'S ACCOUNT WITH OUTFITTER SATELLITE BY SEPARATELY EXECUTED AGREEMENT(S) WILL BE GOVERNED BY THE TERMS AND CONDITIONS IN THE SEPARATELY EXECUTED CUSTOMER ACCOUNT SETUP AGREEMENT (OR RECHARGE AUTHORIZATION FORM). CUSTOMER UNDERSTANDS THAT ONLY CREDIT CARD(S) WITH A SIGNATURE ON FILE MAY BE USED. NOTICE: IT IS NOT NECESSARY TO MAKE AN IMMEDIATE PURCHASE OF A PREPAID VOUCHER TO CHECK THE ABOVE BOX AND AUTHORIZE FUTURE RELOADS ONLINE, BY EMAIL, OR OVER-THE-PHONE.

DESCRIPTION:

A UNIVERSAL CARD ACCOUNT IS A RELOADABLE PREPAID ACCOUNT THAT CAN BE USED ON APPROPRIATELY PROVISIONED SIM CARDS OR TERMINALS ON MANY DIFFERENT NETWORKS INCLUDING: INMARSAT MINI-M, INMARSAT GAN, INMARSAT BGAN, FLEETBROADBAND (FBB), INMARSAT SWIFT BROADBAND (SBB), IRIDIUM, OR THURAYA IP.

FOR EXAMPLE, YOU COULD USE A SINGLE UNIVERSAL CARD ACCOUNT TO ACCESS THE INTERNET ON A FBB TERMINAL AND LATER TO MAKE A VOICE CALL ON AN IRIDIUM HANDHELD PHONE, AS LONG AS BOTH WERE PROVISIONED FOR USE WITH THE UNIVERSAL CARD ACCOUNT. THE RATES IN THE TABLE TO THE RIGHT SHOW STANDARD IP AND VOICE-TO-PSTN CALLS MADE FROM FBB, BGAN, SBB, THURAYA IP, AND IRIDIUM PHONES/TERMINALS, RESPECTIVELY. THE CUSTOMER AGREES THAT UNIVERSAL CARD ACCOUNTS WILL NOT BE USED FOR MOBILE-ORIGINATED COMMUNICATIONS WITHIN THE U.S. OR ITS TERRITORIES.

*NOTE: The Vouchers above have an exact number of "units". The "MB Value" shown is approximated within 0.001 MB. If services other than Standard IP data are used, a smaller number of "units" can be applied towards Standard IP data.

VALIDITY RULES:

THE DATE OF FIRST USAGE OF THE UNIVERSAL CARD MUST OCCUR WITHIN ONE YEAR OF THE MOST RECENT VOUCHER PURCHASE APPLIED TO THE UNIVERSAL CARD ACCOUNT. OTHERWISE, THE UNIVERSAL CARD ACCOUNT EXPIRES AND ALL UNUSED USAGE IS LOST; THERE WILL BE NO REFUND OR PRORATION.

AFTER THE DATE OF FIRST USAGE OCCURS, THE PREPAID ACCOUNT EXPIRES IN 360 DAYS IF NO FURTHER VOUCHER PURCHASES ARE APPLIED TO THE UNIVERSAL CARD ACCOUNT. ALL UNUSED USAGE WILL BE LOST; THERE WILL BE NO REFUND OR PRORATION.
